






# What is currently available for schools?



- Medicines optimisation is all about supporting children and young people so that they get the best possible outcomes from their medicines.
- Supporting pupils at schools with medical conditions. Section 100 of the Children and Families Act 2014 places a duty on governing bodies of maintained schools, proprietors of academies and management committees of PRUs to make arrangements for supporting pupils at their school with medical conditions.
- The SEND reforms introduced by the Children and Families Act 2014 focus on two key themes: greater co-operation between education, health and social care and a greater focus on the outcomes.









## Existing Barriers:

- Currently there is a lack of a standardised approach to health provision
- Great variations exists nationally in health provision for SEND and mainstream schools
- limited financial resources within schools
- increase in medication related errors due to the increased burden and responsibility on teaching and support staff to undertake medicines administration tasks
- a perceived lack of funding/consistent approach in the current commissioning structure for the inclusion of a specialist pharmacy led service to special schools




How can the pharmacy profession support with coproduction/collaboration?

Keeping children and families at the heart of everything we do: Listen to their voices

#### **Kent Model and Local Evidence:**

- Pilot study highlighted that with the appropriate level of specialist pharmacy support the school were largely successful at supporting the safe and effective management of medicines to CYP minimising the risk of errors.
- The specialist pharmacy made appropriate interventions including deprescribing recommendations to the special school which directly supported the school to achieve a 60% reduction of when required (PRN) salbutamol inhalers at school, improving patient outcomes and indirectly minimised the medicines waste burden on the wider health economy.



Kent model criteria which demonstrates/highlights the Ambition, Outcome, Spread, Involvement and Value of the project


# 1. Supports collaboration and coproduction:

- setting free the voices of SEND children and young people (CYP) who are often seen but not heard.
- keeping CYP and their families at the heart of everything we do listening to their voices.
- Clear focus on outcomes that matter most to CYP, their families ensuring the best experience at school without compromising learning time.



# 2. Strengthens the education and healthcare partnership:

- Promotes partnership working thereby turning the vicious cycle of challenges into a virtuous one of opportunities.
- Promotes the vision of the SEND green paper aspirations – developing traction on the national agenda to drive changes.
- Delivers outcomes supporting the NHS long term plan and national projects such as STOMP/STAMP.



## 3. Enhances transformation of pharmacy workforce:

- Promotes the development of a specialist role for pharmacy technicians in an untapped sector of healthcare bringing services to the community.
- Supports integrated working across various options including community pharmacy enhanced services opportunities as well as the use of a specialist pharmacy service.
- Service delivery design supports replication of practice/spread in all special schools and mainstream schools whilst still acknowledging individual bespoke requirements.



Benefits of Community Pharmacy and Specialised Pharmacy Services support for CYP, families and Schools:

- Reducing health inequalities and improving health and wellbeing are major priorities for pharmacy.
- Promotes and supports the STOMP-STAMP agenda in relation to overprescribing and deprescribing considerations for school
- Pharmacists' skills of listening, explaining, advising and questioning are all highly relevant to help identify and support the medicines optimisation needs of CYP with complex health needs in special schools.
- Community Pharmacists are local, accessible and ideally placed to develop close links with CYP, families and their schools:
- Repeat prescription service
- Effective medication reviews which includes considerations for deprescribing (New Medicines Service, Discharge Medicine Service)
- MAR Chart provision
- Medicines Information and Counselling
- Provision of suitable emergency medicine kits for salbutamol and adrenaline auto-injectors in schools.
